This Amendment is hereby entered into by and between U.S. Bank National Association, 800 Nicollet Mall, BC-MN-H15F, Minneapolis Minnesota, 55402, (hereinafter "Contractor") and The University of Central Missouri (hereinafter "UCM"), for the purpose of amending the Contract dated May 12, 2017, executed under UCM Contract No. 2017-UCM-00020, for ID Card - Banking Services.

WHEREAS, the original term of the Contract is September 4, 2017, through September 3, 2024; and

WHEREAS, the parties hereby extend the Contract for an additional eight (8) month and eleven (11) day term beginning September 4, 2024, through May 15, 2025; and

WHEREAS, the parties hereby agree that the Annual ID Card Payment will be prorated based on the end date of May 15, 2025 (253 days (69.032%) of the annual rate) for a total amount of \$69,315.06; and

WHEREAS, the parties hereby agree that the full \$3,000.00 annual scholarship fund payment will be made under the terms of this amendment.

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in the Contract, under UCM Contract No. 2017-UCM-00020 and stated herein the parties agree as follows:

- 1) The parties hereby extend the Contract for an additional eight (8) month and eleven (11) day term beginning September 4, 2024, through May 15, 2025.
- 2) The parties hereby agree that the Annual ID Card Payment will be prorated based on the end date of May 15, 2025 (253 days (69.032%) of the annual rate) for a total amount of \$69,315.06.
- 3) The parties hereby agree that the full \$3,000.00 annual scholarship fund payment will be made under the terms of this amendment.
- 4) All other terms of the Contract, not in conflict with this Amendment, shall remain in full force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns. This Amendment may be executed in two or more identical counterparts and delivered by .pdf or other comparable electronic format, with the same force and effect as if all required signatures were contained in a single, original instrument.


