ROGER J. BEST, Ph.D. President of the University of Central Missouri

An experienced academic and administrative leader with years of college-level teaching experience, Roger J. Best, was named the 16th president of the University of Central Missouri by the Board of Governors on Nov. 5, 2018. He had served as UCM's interim president since Aug. 1 of the same year.

Best joined UCM in August 1995 as an assistant professor of finance and was promoted through the faculty ranks to become a professor in 2005. He was named chair of the Department of Economics and Finance in 2003; associate dean of the Harmon College of Business Administration in 2008; and dean of the college in 2010. Following extensive restructuring of academic programs, Best became dean of the newly formed Harmon College of Business and Professional Studies in 2011. His strong business acumen contributed to him becoming Interim Senior Vice President for Finance and Administration in August 2017, and concurrent with a university administrative reorganization, he was appointed Executive Vice President and Chief Operating Officer in January 2018.

Throughout his UCM service, Best has shared his financial and administrative expertise to the benefit of the University and has supported innovative programs that enrich the student experience, often imbuing their education with real world experience and perspectives. As president, he helped guide UCM through one of the most challenging financial times in the institution's history; led the University through a global pandemic; provided leadership in a campus-wide strategic planning initiative to serve as a blueprint for the University's future; and worked to secure donor, state, and federal funding for a number of capital projects and infrastructure upgrades on campus.

The first in his family to earn a college diploma, Best graduated from Georgia College in Milledgeville, where he earned a Bachelor of Business Administration degree with a major in management. Advanced study led to a Ph.D. in finance from Florida State University in Tallahassee.

PHIL BRIDGMON, Ph.D. Provost and Vice President for Academic Affairs; Professor of Political Science

Shari Bax was appointed Vice Provost for Student Experience and Engagement (SEE) on Aug. 1, 2011, and Vice President for Student Experience and Engagement in July 2019. Bax came to UCM in 1997 as Associate Professor of Political Science, and was promoted to Professor in 2011. Her previous administrative responsibilities include serving as the campus coordinator for the American Democracy Project, the academic consultant and curriculum coordinator for Missouri Boys State and Missouri Girls State, and as the coordinator for Political Science. As a faculty member, Bax advised multiple student activities and helped organize a wide array of programs and activities.

She received several awards including Advisor of the Year from the Office of Student Activities; Greek Advisor of the Year (twice) from Fraternity and Sorority Life; Faculty Achievement Award and Meritorious Service Award from the College of Arts, Humanities, and Social Sciences; and the Governor's Excellence in Teaching Award. She holds a Bachelor of Arts in Political Science from the University of the South, and a Master of Arts and Doctorate of Philosophy in Political Science from the University of Tennessee. In her current role, she reports to the President and works with the directors of departments and offices within student services, student auxiliaries, student activities and recreation, the Center for Multiculturalism and Inclusivity, and Dept. of Public Safety. The Student Experience and Engagement division's mission is to facilitate student success by providing student-centered programs, facilities and services that promote educational, professional, and personal development.

Among its many goals, SEE seeks to help students locate and receive the assistance they need to be academically and personally successful, and have a safe and supportive collegiate experience that promotes their personal growth.

Phil Bridgmon is the Provost and Vice President for Academic Affairs and Professor of Political Science. In addition to the Office of General Counsel, UCM's offices of Environmental Health and Safety and Accessibility Services fall under Chapman's oversight. Chapman and her husband, Justin, reside in Warrensburg with their two children.

Howdeshell comes to Central Missouri after an impressive 12-year tenure at Northern Arizona University in Flagstaff, Ariz., most recently serving as the Senior Associate Athletic Director for Administration and Capital Projects.

During his stint at Northern Arizona, Howdeshell helped oversee all aspects of a \$25 million operating budget, led \$60 million of capital projects, coordinated capital fundraising efforts, served as the sport administrator for football, and supervised the athletics business office, strength and conditioning and video staffs.

Howdeshell, who hails from Cuba, Mo., also has a proven ability to generate revenue beyond traditional fundraising. He worked collaboratively with student and university leadership to pass NAU's first-ever athletic student fee, generating more than \$3.1 million in incremental revenue its first year. Howdeshell also helped secure the renewal of the department's apparel contract, the largest in the Big Sky Conference at the time, and NAU's first-ever multimedia rights partnership with Learfield, which has enhanced NAU Athletics' visibility, branding, and corporate sponsorship revenue.

In addition, he spearheaded several strategic financial initiatives and was involved in many student-athlete welfare projects relating to gender equity and the student-athlete experience.

Howdeshell previously served NAU as the Associate Athletic Director for Administration and Capital Projects, Assistant Athletic Director for Administration, and as the Director of Football Operations. He began his athletics career as a student manager and video coordinator at Missouri State University in Springfield, Mo.

The son of two first-generation, non-traditional college students, Howdeshell earned a bachelor's degree from Missouri State in history education (2010), and a master's degree in educational leadership (2013) and Doctor of Educational Leadership (2020), with distinction, from NAU.

Howdeshell and his wife, Hiliary, have three sons: Peter, Benjamin, and Max.

In this capacity, he works closely with the university president and senior administrators to craft legislative priorities and communicate them. He helps identify state and federal fiscal resources for which UCM may be eligible; provides legislative reports to the Board of Governors; summarizes legislative bills and potential impact on UCM; and coordinates responses to legislators' and governors' office inquiries.

Pearce's long record of public service in Missouri government includes eight years in the Missouri Senate, where he represented constituents from the 21st and 31st senatorial districts. He also served for six years in the Missouri House of Representatives before becoming a senator.

His political work included chairing the Senate Education Committee, and while he was serving as a state representative in 2003 he was appointed as a commissioner to the Missouri Higher Education Compact (MHEC). He was reappointed in 2011, 2013, and 2015, and held leadership posts that include serving as vice chair, treasurer, and chair of the Compact. Governor Parson appointed Pearce to serve on the Midwestern Higher Education Compact again in June 2022 for a four-year term.

Prior to joining UCM, Pearce served from January 2017 to September 2019 in the office of State Treasurer Scott Fitzpatrick and his predecessor, Eric Schmitt. His duties included working on the legislative agenda and helping promote the MOST 529 Education Savings Plan and MO ABLE, a savings plan for persons with disabilities.

A graduate of the University of Missouri, Pearce has worked in the local banking industry, and also served as a former executive vice president of the Greater Warrensburg Area Chamber of Commerce.
