### University of Central Missouri Board of Governors Special Plenary Session January 21, 2020

The University of Central Missouri (UCM) Board of Governors convened in Special Plenary Session on Tuesday, January 21, 2020, at 11:00 a.m. in the Elliott Student Union, Room 237A on UCM's main campus in Warrensburg, Missouri. Presiding over the meeting was Board President John Collier. Other Board members present included Governors Stephen Abney, Mary Long, Mary Dandurand, Gus Wetzel II, Casey Short, and incoming Board member Kenneth Weymuth. Participating in the meeting by phone was Governor Marvin E. Wright. Others in attendance were University President Roger Best, General Counsel Lindsay Chapman, Assistant Board Secretary Monica Huffman, Associate Circuit Court Judge Brent Teichman, and outgoing Board member Walter Hicklin.

#### <u>Call to Order</u> – Agenda Item No. 1

Mr. Collier called the meeting to order and determined a quorum was present to conduct business.

#### Oath of Office - New Board Member - Agenda Item No. 2

Associate Circuit Court Judge Brent Teichman administered the Oath of Office to newly appointed Board member Kenneth Weymuth.

# Recognition of Outgoing Board Member Walter Hicklin and Award of Emeritus Status – Agenda Item No. 3

The Board of Governors recognized outgoing Board member Walter Hicklin for his years of service on UCM's Board. Mr. Collier read and presented Mr. Hicklin with a proclamation summarizing the many contributions Mr. Hicklin made to the Board's work and to the University during his tenure as a Board member.

Following Mr. Hicklin's brief remarks, Ms. Dandurand made a motion to grant Mr. Hicklin Governor Emeritus status. The motion was seconded by Mr. Abney and carried unanimously.
