

UCM Financial Agreement

I agree to pay all University of Central Missouri debts and charges pursuant to UCM policies. I understand that the University is advancing value to me in the form of educational services and that my right to register is expressly conditioned upon my agreement to pay the costs of tuition, fees and all other charges and any additional late fees or collection costs when those charges become due. Regardless of an expected reliance on third-party resources, including but not limited to financial aid, family gifts, employer reimbursement or any other external resource, I remain personally responsible for paying any and all outstanding balances which collectively represent my student financial obligation. I understand that enrollment constitutes a binding obligation between the student and UCM and constitutes an educational loan pursuant to the U.S. Bankruptcy Code at 11 U.S.C. §523(A)(8).
