Congratulations. University of Central Missouri has been awarded a grant for the purpose of addressing teacher recruitment. Teacher recruitment and retention are two critical goals of DESE's strategic plan. DESE established these goals in direct response to the challenges in the teacher workforce in Missouri. Teacher recruitment grants are a specific investment in accomplishing these goals and rely on partnership and collaboration between educator preparation programs, community colleges and LEAs across the state.

Teacher Recruitment Grant Amount: \$40,000

Grant Outcomes: The Department directs that these funds be used for the purpose of positively impacting recruitment into teacher education programs by developing stronger partnerships and improving collaboration, by implementing recruitment and selection activities, providing preparation and support to those interested in the teaching profession, and by evaluating any and all recruitment strategies. The Department will require evaluation information from your EPP or community college on activities/strategies implemented and evidence of success of the strategies funded by the Teacher Recruitment Grants. <u>All vendors MUST register in the MissouriBUYS</u> <u>system. No payment can be made to a vendor</u> <u>until the registration has been completed.</u>

MissouriBUYS is a web-based statewide eProcurement system implemented by the State of Missouri. Vendors will need to register through the MissouriBUYS system. If a vendor is a business or individual providing a product/service (including honorarium payment) and/or attending a meeting (including committee meetings' travel), they will need to register thru MissouriBUYS. The link to the MissouriBUYS website is: <u>https://missouribuys.mo.gov/</u>

Attached are instructions for individuals (whom our Office is contracting with for services) to follow when registering in the MissouriBUYS system and the step-by-step directions are as follows:

- 1. Go to the MissouriBUYS website (<u>https://MissouriBUYS.mo.gov</u>) and click on Register.
- 2. An informational screen will display and the individual just needs to click on the Yes, I agree box and then click Next.
- 3. On the Organization Information screen, the individual must leave the Parent/Holding Company button selected. The individual then must enter their Social Security Number, Legal Name, Address, City, State, and Zip Code. Under Type of Business, the individual must select Individual/Sole Proprietor from the dropdown menu. Lastly, the individual must click on Now under Internal Revenue Service W-9 Form and ACH-EFT Payment Information and upload a signed and completed W-9 form to become an approved vendor. The last three sections on this screen are optional and do not have to be completed during registration. Click Next at the bottom of the screen.
- 4. On the Organization Contact Information screen, the individual must enter their First Name, Last Name, Phone Number or Fax Number, Email Address, and Password. Click Next at the bottom of the screen.
- 5. On the Select Commodity/Service Codes screen, the individual must select the (0000000) Unknown code. Once the code is selected, it will appear at the bottom of the screen under Selected Categories. To complete the registration process, click on Process My Registration. The individual will receive an email from Perfect Commerce/WebProcure confirming submission of their registration in MissouriBUYS.
