ADMISSIONS CHECKLIST

Alternative Pathways to Certification is designed to prepare the candidate for a teaching position and

provide educational support that will lead to certification in the state of Missouri. Complete an online application for admission to UCM Graduate Studies, www.ucmo.edu/graduate Make arrangements for all official transcripts to be sent to UCM Graduate Studies. The mailing address is Graduate Studies, WDE 1800, University of Central Missouri, Warrensburg, MO 64093. Note: Official transcripts from all academic institutions attended are required for admission to UCM. If you send official transcripts to Clinical Services and Certification staff for your transcript evaluation, the transcripts will be forwarded to Graduate Studies staff. If you are pursuing a graduate degree, your application is sent to the program coordinator for review after you have been admitted to Graduate Studies. The program coordinator will contact you when you've been admitted to the degree program and will assign a graduate advisor to you. Complete the background check, <u>Fingerprinting - Certification and Student Teaching</u>, or send copy of substitute certificate to Clinical Services and Certification staff. Create an Educator Profile through DESE Web Applications. Access instructions at the following website, https://www.ucmo.edu/cert/teacher/profile.cfm When your fingerprint information is listed on your DESE Educator Profile, send a copy of your complete Educator Profile to Mrs. Cavanah, cavanah@ucmo.edu Information about financial assistance is available at www.ucmo.edu/sfs After your transcripts have been evaluated and a certification plan has been created, the certification plan will be shared with you via Google. Once admitted, you are eligible for enrollment. You should receive an email from the Technology Support Center containing your 700 number also known as your student ID number. A separate email from the Technology Support Center will contain a link to retrieve your temporary MyCentral password. When you first login to MyCentral, you will be asked to enter a new password. Enrollment is completed through MyCentral accessible from www.ucmo.edu by selecting "Campus Links" in the upper right corner of the page. Note: If you are not able to self-enroll through MyCentral, contact Mrs. Cavanah, cavanah@ucmo.edu, for enrollment assistance. An email message including your first and last name, your 700 number and requesting enrollment in the class(es), the digit CRN for the class(es) would be best. Mrs. Cavanah will serve as your advisor for questions about certification or your certification requirements. You will also work with an assigned faculty advisor regarding the courses on your certification plan.

Common Abbreviations and Terms

Advanced Degree – a master or higher degree

Alt Cert – Student pursuing Alternative Pathways to Certification

Clinical Experience – can be same as student teaching

DESE – Missouri Department of Secondary and Elementary Education

UCM Policy – Graduate Student Load Per Semester

The normal load per semester for a graduate student is 9 to 12 semester credit hours. A graduate student may enroll in a maximum of 16 credit hours per fall or spring semester and a maximum of 12 credit hours during the entire summer semester, including both undergraduate and graduate level courses.

UCM Policy – Full Time Graduate Student

A graduate student is considered full-time if enrolled in nine or more credit hours per fall and spring semesters or six semester hours in the summer session.

Semester Enrollment

Enrollment must be a minimum four graduate hours or six undergraduate hours or a combination of graduate and undergraduate hours totaling six hours in classes listed on your certification plan to be eligible for financial aid. Please contact <u>Student Financial Services</u> for information about financial aid.

Note: Financial aid will <u>only</u> apply to classes <u>required</u> for certification as listed on your certification plan or required for your master's degree.

Class Schedule/Enrollment

The class schedule for each semester can be viewed by accessing www.ucmo.edu and selecting the Academic tab. Schedule of Courses is at the bottom of the first column on the left side of the page.

MyCentral

MyCentral can be accessed from any UCM website by selecting "Campus Links" in the top right of the page. MyCentral provides access to class schedules, enrollment, financial services, payment center and other student related information.

Blackboard

Blackboard can be accessed from any UCM website by selecting "Campus Links" in the top right of the page. Blackboard is used by most classes offered through UCM.

Enrollment Validation Policy

The <u>Enrollment Validation Policy</u> takes place every semester. It impacts both undergraduate and graduate level students/classes. It applies to all full semester classes (16 week classes), all regularly scheduled first-half and second-half classes (eight week classes), and each of the five summer

sessions. It applies to face-to-face, online, and hybrid classes.

Therefore, it is critically important that students frequently check their <u>student e-mail account</u> and MyCentral for announcements during the week before classes begin and during the first several weeks of the semester or summer session.

Records Retention

The Office of Clinical Services and Certification staff will keep your Alternative Pathways file as long as you are pursuing classes required for certification at University of Central Missouri. If no classes required for certification are completed at the University of Central Missouri 10 years from the issue date of the official certification plan for the candidate, the candidate's file will be shredded.

If you have not enrolled in classes at the University of Central Missouri within the past year, your status will become "inactive" and a hold will be placed on your student account. The only way to remove this hold is to reapply. There is not an application fee to reapply for admission to Alternative Pathways or MAT programs.

Classes at other Universities or Community Colleges

If you would like to take a class required for certification at another university or community college, you must receive permission from Clinical Services and Certification staff before enrolling in the class(es). Please send the class prefix, class title, and academic institution to Clinical Services and Certification staff for approval. Classes taken without prior approval may not be accepted toward certification.

Through UCM's Course Transfer Equivalencies https://www.ucmo.edu/corequiv/ you can search by the UCM course/prefix number or by the transferring institution's course/prefix number.

Alternative Pathways to Certification and Advanced Degree Programs

Please note that all certification plans for Alternative Certification are subject to change if the Missouri Department of Elementary and Secondary Education (DESE) makes changes to certification requirements.

You do not have to pursue a master's degree in order to pursue Alternative Pathways to Certification. An advanced degree would be beneficial to you as a teacher and would increase your teacher salary. If you currently possess a master's degree, you have the opportunity to pursue an education specialist degree in Career and Technical Education.

Master of Arts in Teaching (MAT) Degree

Majority of the graduate level professional education classes listed on your certification plan are also requirements for the Master of Arts in Teaching degree. Those professional education classes will apply towards your chosen certification area and towards the Master of Arts in Teaching degree. Master of Science (MS) in Career and Technical Education (CTE)

The Master of Science in Career and Technical Education also offers an education specialist program. You'll meet with your graduate advisor to determine how many of the professional education classes listed on your certification plan can also apply towards the Master of Science in Career and Technical Education degree. Additional information for the Master of Science in Career and Technical Education degree is accessible at www.ucmo.edu/msae/programs by selecting Graduate under the Programs heading.

Master of Science in Education (MSE) in Early Childhood - Teaching Option

If pursuing Early Childhood Education B-3 certification, you should consider our Master of Science in Early Childhood Education degree program. Like the other degrees listed here, majority of the the Master of Science in Education in Early Childhood coursework overlaps with what is required for certification if taken at the graduate level. Additional information about the Master of Arts in Teaching degree is accessible here.

Master of Science (MS) in Library Science and Information Services

Alternative Pathways to Certification will fulfill the professional education courses and test requirements for certification as a library media specialist. Most of the classes required for the Master of Science in Library Science and Information Services fulfill the content area course requirements for certification as a library media specialist. Master of Science in Education (MSE) in Special Education K-12

If pursuing Special Education certification, you should consider our Master of Science in Education in Special Education K-12 degree program. Like the other degrees listed here, majority of the the Master of Science in Education in Early Childhood coursework overlaps with what is required for certification if taken at the graduate level. Additional information about the Master of Arts in Teaching degree is accessible here.

Clinical Experience Requirement for Certification

An eight hour clinical experience in your content area is required for certification in the state of Missouri. The clinical experience is a culminating experience which should be completed during your last semester. The clinical experience can be completed only during a fall semester or during a spring semester.

Candidates pursuing the Master of Science in Library Science and Information Services degree and certification as a Library Media Specialist will complete LIS 6830, Internship in School Libraries, eight hours, as the clinical experience. Contact Dr. Rene Burress, Assistant Professor, by email to burress@ucmo.edu for information about the internship.

Student teaching during a fall or spring semester

- a. Your student teaching experience will be similar to an undergraduate student completing a semester of student teaching.
- 1. Complete the Request to Student Teach form accessible at https://www.ucmo.edu/college-of-education/clinical-services-and-certification/student-teaching/
- b. The request must be submitted one year in advance (October 1st for fall semesters and April 1st for spring semesters).
- c. You will receive information regarding dates for preliminary meetings and checklist meetings for all student teachers.
- d. Attend one of the Preliminary Meetings for Student Teaching during the semester prior to your planned student teaching semester.
- e. Attend one of the Checklist Meetings scheduled during the semester prior to your planned student teaching semester. These meetings are specific to Alternative Pathways candidates.
- f. Student Teaching staff will enroll you in a total of eight credit hours.
 - i. If you are pursuing the Master of Arts in Teaching degree, you will enroll in FLDX 5468, three hours of graduate credit, and Student Teaching staff will enroll you in a five hour

- FLDX undergraduate student teaching course to fulfill clinical experience requirements.
- ii. If you are pursuing the Master of Science in Career and Technology Education degree, you will enroll in CTE 5022, Teaching/Administration Internship, three hours of graduate credit, and Student Teaching staff will enroll you in a five hour FLDX undergraduate student teaching course.
- g. Alternative Pathways candidates will be responsible for the same requirements as undergraduate students during their student teaching semester.
- h. You will be observed by your assigned University Supervisor. As part of the observations, you'll complete an introductory assessment, three formative assessments and one summative assessment.
- The Missouri Educator Evaluation System (MEES) will be completed during your student teaching semester.

Teaching on a provisional certificate during a fall or spring semester

- You will remain in your own classroom while completing your clinical experience semester.
- 3. Complete the Request to Student Teach form accessible at https://www.ucmo.edu/college-of-education/clinical-services-and-certification/student-teaching/
- 4. The request must be submitted one year in advance (October 1st for fall semesters and April 1st for spring semesters).
- 5. Student Teaching staff will enroll you in a total of eight credit hours.
 - a. If you are pursuing the Master of Arts in Teaching degree, you will enroll in FLDX 5468, three hours of graduate credit, and Student Teaching staff will enroll you in a five hour FLDX undergraduate student teaching course to fulfill clinical experience requirements.
 - b. If you are pursuing the Master of Science in Career and Technology Education degree, you will enroll in CTE 5022, Teaching/Administration Internship, three hours of graduate credit, and Student Teaching staff will enroll you in a five hour FLDX undergraduate student teaching course.
- 6. You will be observed in your own classroom by an assigned University Supervisor and the building principal or the building principal's designee.
- 7. The Missouri Educator Evaluation System (MEES) will be completed during your clinical experience semester.

Missouri Content Assessment (MoCA)

Candidates seeking certification in Missouri are required to achieve a passing score on the appropriate Missouri Content Assessment for the specific area of certification. Information and registration for the content assessment can be accessed at www.mo.nesinc.com The content assessments are specific to each certification area.

Khan Academy offers free online courses, lessons, and practice tests for every subject and grade level. The information on the Khan Academy website, www.khanacademy.org, is a good resource to prepare for a content assessment.

The specific MoCA must be taken prior to the planned clinical experience semester. November 1St if clinical experience is in spring semester and April 1St if clinical experience is in fall semester.

The MoCA for your specific certification area must be passed to be eligible for an initial teaching certificate.

Once you have completed your certification requirements and received an Initial Professional Certificate (IPC), you can add some certification areas by passing the specific MoCA for the additional area. After

passing the content assessment for the additional area, submit the "additional" application to DESE through DESE Web Applications to add the additional area of certification. Not all certification areas can be added by passing the specific MoCA.

Note: Individuals holding a Missouri professional teaching certificate (IPC, CCPC) or lifetime teaching certificate in a secondary content area (Agriculture Education, Business Education, English, Industrial Technology, Mathematics, Science, Social Science, or Speech/Theatre) may add on middle school certification in the same content area by achieving a passing score on the Professional Knowledge Middle School, test code 062.

Employment Resources

<u>University of Central Missouri Career Services – www.ucmo.edu/career</u>

<u>Handshake</u> is an online recruiting resource managed by Career Services. Candidates can access Handshake to search and apply for positions at regional school districts. Information regarding recruiting events hosted by the Career Services Center can also be found online through Handshake.

Regional Education Application Placement Program (R.E.A.P) - www.moreap.net

This voluntary organization requires school districts to pay a membership fee to post vacant positions in the district. Applicants are able to view job vacancies in various school district without completing the MoREAP application. If you want to apply for a position, you must complete the MoREAP application.

Missouri Teaching JOBS - www.moteachingjobs.com

Missouri Teaching Jobs lists vacant positions by region in Missouri. Each school district with vacancies are listed as part of the specific region. You can search for job vacancies without registering. You must register to apply for vacant positions.

Initial Professional Certificate (IPC)

This four-year teaching certificate is only valid in the state of Missouri but can be transferred to other states.

Eligibility for an initial professional teaching certificate requires

- 1. Candidate must complete all courses required for certification earning a grade of C or higher in each course.
- 2. Candidate must pass the MoCA specific to chosen certification area.
- 3. Candidate must pass the MEES specific to chosen certification area.
- 4. Candidate must have a minimum 3.0 cumulative grade point average in all professional education courses completed.
- 5. Candidate must have a minimum 3.0 cumulative grade point average in content area courses specific to chosen certification area or obtain a passing score on the designated MoCA.

Clinical Services and Certification staff will send instructions for applying for an initial certificate to the candidate during the last semester of classes.

Career Continuous Professional Classification (CCPC)

After completing four years of DESE approved teaching experience, you are eligible for the Career Continuous Professional Classification, valid for 99 years. Submit the "upgrade professional" application to DESE through DESE Web Applications, www.dese.mo.gov. There is a \$35 application fee.
