

**HEERF - Student Financial Aid
Quarterly Progress Report
January 1, 2022 - March 31, 2022**

1. An acknowledgement that the institution signed and returned to the Department the Certification and Agreement and the assurance that the institution has used, or intends to use, no less than 50 percent of the funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students.

The University of Central Missouri (UCM) signed and submitted the Certification and Agreement document to the US Department of Education, through a Grants.gov submission, on April 15, 2020. UCM agreed to use no less than 50 percent of these funds for Emergency Financial Aid Grants to students in accordance with Section 18004(a)(1) of the CARES Act and agreed to comply with all aspects of this certification, including maintaining employees.

2. The total amount of funds that the institution will receive or has received from the Department pursuant to the institution's Certification and Agreement [for] Emergency Financial Aid Grants to Students.

UCM received its Grant Award Notifications (GAN) on April 25, 2020 in the amount of \$3,454,160 for HEERF I, on January 17, 2021 in the amount of \$3,454,160 for HEERF II, and on May 21, 2021 in the amount of \$10,699,104 for a total of \$17,607,424. All funds have been or will be used to issue direct student financial aid grants.

3. The total amount of Emergency Financial Aid Grants distributed to students under Section 18004(a)(1) of the CARES Act as of the date of submission.

As of March 31, 2022, \$17,594,520 in total has been issued to students under the Student Aid Portion of HEERF I, HEERF II, & HEERF III. Within this quarter, \$5,800 was returned to the account by students who failed to deposit their checks within the 180 days that they were valid.

4. The estimated total number of students at the institution eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 and thus eligible to received Emergency Financial Aid Grants to students under Section 18004(a)(1) of the CARES Act.

UCM identified 14,252 students who met the eligibility criteria based on student classification, credit hours enrolled, FAFSA status and students who were not previously eligible for HEERF aid due to restrictions from CARES and CRRSAA funding.

From this quarter, thirty students' checks expired and the funds were returned to the grant.

5. The total number of students who have received an Emergency Financial Aid Grant to students.

Thirty students did not deposit their checks and the \$5,800 in aid was returned to the grant to be issued to other students.
