Ms. Muder,

UCM appreciates the opportunity to provide follow up information regarding Skyhaven Airport's (the "Airport") financial statements and other outstanding concerns from licensees that have been brought to the FAA's attention. UCM remains committed to resolving these concerns quickly, efficiently, and without interfering with UCM's ability to manage the Airport.

First, regarding the financial statement questions, the operations and function of the Airport are unique because the Airport is owned and operated by the University of Central Missouri. The Airport serves as the educational facility for UCM's Aviation Program which includes flight instruction and maintenance instruction. Additionally, the Airport is open for use by the public which includes fuel sales, use of public spaces such as the terminal, licensing of hangar spaces or tie-down spaces, etc. That being said, the University of Central Missouri has three main organizations under its umbrella that operate at the Airport; Airport Operations, the Flight School, and Aircraft Maintenance (the University operates an aircraft maintenance hangar and mechanics shop for educational purposes as part of the aviation program and to service flight school aircraft only, that is separate from hangars available to licensees). The financial statements provided to the FAA were for the Airport Operations but may show where there is overlap with other organizations and their accounts that are under the overarching umbrella of UCM's financial accounts and management.

Please see our responses, below, to your related requests for information.

# Are the financial statements submitted from FY18-FY24 solely for the Airport Operations/Sponsor or are the FBO's costs commingled in the expense line items?

The financial statements provided to the FAA were solely for the Airport Operations. Fuel for the operation of the Airport is purchased by Airport Operations. The revenue earned from the sale of fuel to the public is accounted back into the Airport Operations budget and used for Airport Operation expenses, in accordance with Grant Assurance (25).

### Is the Airport FBO Reimbursement line item a source of Revenue, such as lease payments?

The Airport FBO Reimbursement line item is a source of revenue. It is a reimbursement from the Flight Operations organization to the Airport Operations organization for the use of fuel, hangaring, tie-down, etc. Similar to the public's use of the Airport Operations services, the Flight Operations pays for those services provided.

### What is the purpose of the Interfund Transfer Out?

Interfund Transfer Out is Airport Operation purchases made by Airport Operation for services performed by other UCM departments. The most frequently used service by Airport Operations at UCM is the Facilities, Planning, and Operations (FPO) Department which provides repairs, maintenance, and materials for plumbing, HVAC, etc. However, please note that in FY18, the Interfund Transfer Out included a Debt Service. The Debt Service was a payment to the University for interest and principal on a bond the University issued in 1999. A portion of the proceeds from the bond were used to purchase, acquire, construct, improve, and renovate the Airport and airplanes for the University's flight instruction program.

The Airports Financial Compliance Division requests the sponsor provide a complete set of financial statements; missing were the balance sheet, statement of cash flows, and statement of net assets.

UCM's Department of Accounting does not track individual balance sheets or cash flows for each individual department and does not require departments to do so. This level of tracking is not required under the Government Auditing Standards and UCM is unable to provide that level of detailed information. However, UCM has attached a statement of fixed assets located at the Airport. Please note that the fixed assets related to the Airport include more than those that were purchased or owned by Airport Operations and would include assets owned wholly by UCM, the Flight Operations, the Maintenance Hangar, or a different UCM organization, such as the Office of Technology.

# UCM is working with Mr. to resolve his requests.

Regarding our discussion last week regarding Mr. and in response to your March 12, 2025 email forwarding a third party's inquiry about access to Mr. as a mechanic, please see attached Mr. Holland's February 21, 2025 response to Mr. email. Mr. Holland explained the process to apply to conduct commercial business within licensed hangars and included attachments to the Rules and Regulations and the application. The attachments are not included again here, as they're online and have also been previously provided to the FAA.

Following this exchange and consistent with the procedure, on March 7, 2025, Mr. submitted an application to perform A&P mechanic services for hire in his licensed hangar. On March 10, 2025, follow-up emails were sent to Mr. indicating that his application was received and was being processed. These emails are also attached. Mr. application is currently following the procedure laid out in the Rules and Regulations that we reviewed with the FAA.

Mr. was not aware of Mr. application was submitted shortly after you and I visited last week. Perhaps Mr. was not aware of Mr. application or ability to proceed at the time he sent his email to you. Regardless, UCM has shown that Mr. application of a commercial activity has moved toward resolution. Mr. as been able to access UCM's process for application. He has not raised any concerns associated with the submission process and the application is proceeding forward.

Furthermore, UCM believes it is important to reiterate that it has welcomed communications with Mr. or his counsel on this issue for many months, including before the filing of the Part 13 Complaint. While Mr. Holland did not respond to Mr. email on October 9, UCM contacted Mr. attorney prior to the FAA's involvement to discuss a second agreement for the operation of a commercial business. UCM received no response. Additionally, UCM has repeatedly asked Mr. if he would like to negotiate or have those discussions on behalf of his client to resolve Mr. concerns and Mr. declined. UCM remains open and willing to work with Mr. and Mr. as his application and commercial operations are considered and resolve any pending concerns.

In our most recent communications, you indicated that it appears that we are close to resolution of the Part 13 Complaint but that these and a few other questions remained before it concludes. Should the FAA still have any other outstanding concerns, I ask that you please send me a list of these concerns so that I can work with UCM to address them and then stand ready to discuss them further with you, and counsel for the complainants if desired.

I have also attached the application for Commercial Operations. Section 3 of the Rules and Regulations manual contains the minimum standards and the application process. In regard to your question about performing A&P services on personally owned aircraft at Skyhaven, Section 2-2.G of the Rules and Regulations Manual details the process for requesting the use of the designated maintenance hangar (Hangar 27) and the Appendix, section 4-2 contains the maintenance hangar agreement that a licensee can submit or request for use of that space. In the event that hangar is not available or circumstances prevent the aircraft from being serviced inside of the maintenance hangar, we will provide accommodations as necessary with appropriate waivers/acknowledgments for use of the licensee's hangar for maintenance. That process is detailed in Section 2-2.G.1 of the Rules and Regulations Manual. If you have any questions please let me know. I understand that there are now agreements available for hangar tenants to conduct this activity. Please forward me the agreement that is available.
