Vendor Guidelines and Application

Ø Merchandise for sale will be American Indian oriented and must meet the Pow Wow Committee's approval. All mediums of artwork and crafts, as well as American Indian craft and regalia supplies are welcome.

Ø It is illegal to market an art or craft item using the name of a tribe if a member, or certified Indian artisan, of that tribe did not actually create the art or craft item. Vendors should have signage clearly indicates if the items are "Indian made" or "Replicas".

Ø Events begin at noon. You may begin setting up at 10:00am.

Ø The Vendor fee is \$50 for a single booth (10'X10'). The Vendor fee is \$75 for a double booth (10'X20"). Make check or money order payable to Trading Moon Pow Wow.

Ø We will provide tables and chairs; specify numbers below. Spaces will be issued on a first come-first served basis to screened applicants – judged by postmark or by the date the fee is paid.

Ø Vendors will receive an official receipt for payment at the time of their arrival at the Pow Wow.

Ø No food vendors; only Arts and Crafts.

Ø All vendor fees are non-refundable.

Ø The Trading Moon Pow Wow and the University of Central Missouri are NOT responsible for Accidents, Theft or Damage of any kind.

Ø ABSOLUTELY NO DRUGS, ALCOHOL, KNIVES OR FIREARMS! No smoking in the venue.
